is hereby approved and is hereby adopted into membership of the Tohono O'Odham Nation.

The foregoing resolution was passed by the Tohono O'odham Council on the 7th day of November, 1988, at a meeting at which a quorum was present with a vote of 806.5 for; -0- against; 833.5 not voting; and 02 absent; pursuant to the powers vested in the Council by Section 2 of Article II and Article VI Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
