Education Conference)

2 WHEREAS, the Human Resources Development Committee of the
3 Legislature is continuing to address serious concerns
4 regarding the operation of the BIA School System on
5 Tohono O'Odham; and

6 WHEREAS, it is essential that the Committee be fully informed of
7 current trends and developments in education in order to
8 adequately provide the Legislative Council with
9 recommendations to appropriately respond to education
10 issues.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
12 Council that the Human Resources Development Committee
13 is hereby authorized to select two members to attend the
14 "National Indian Education Conference to be held on
15 November 13-17, 1988.

16 BE IT FURTHER RESOLVED that the expenses identified are hereby
17 authorized to be paid from the Training Account of the
18 Legislative Council's budget.

19 The foregoing Resolution was presented to the Tohono O'odham
20 Council on the 7th. day of November, 1988 at a meeting at which
21 a quorum was present with a vote of 544.0 for; 937.0 against;
22 159.0 not voting; and -0- absent, failed to pass because it did
not receive a majority of the votes cast as required by Section 2
of Article V of the Constituion of the Tohono O'Odham Nation.
