

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 173-88)

RES. NO. 306-88

1 WHEREAS, the Tohono O'Odham Legislative Council did by Resolution
2 No. 173-88 approve execution of a lease for a term of
3 ten years with the Arizona Department of Transportation
4 covering the premises known as Tracy's Highway
5 Maintenance Camp, located in the Pisinemo District; and

6 WHEREAS, the lease provides for annual rental payments to be made
7 to the Treasurer of the Tohono O'Odham Nation; and

8 WHEREAS, Council Resolution No. 173-88 directs that the annual
9 rental payments be divided and shared equally between
10 the Tohono O'Odham Nation and the Pisinemo District; and

11 WHEREAS, the Pisinemo District Council has by its Resolution No.
12 6-88 reminded the Legislative Council that the foregoing
13 direction of the Legislative Council ignores its earlier
14 direction contained in Ordinance No. 02-83 which
15 provides that all proceeds accruing from leases of
16 tribal lands, which are fixed and not computed on a
17 portion or percentage of revenue, and which annually
18 aggregates \$9,000 or less, shall be fully credited to
19 and expended by the District in which the lands are
20 located.

21 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
22 Legislative Council hereby amends and corrects
23 Resolution No. 173-88 to provide that all annual rental
24 payments made to the Treasurer of the Tohono O'Odham
25 Nation pursuant to the Tracy's Highway Maintenance Camp
26 Lease be deposited and credited in full to the account
27 of the Pisinemo District in accordance with the
28 provisions of Ordinance No. 02-83.

29 The foregoing Resolution was passed by the Tohono O'odham Council
30 on the 7th. day of November, 1988 at a meeting at which a quorum
31 was present with a vote of 1,180.5 for; 147.5 against; 312.0
32 not voting; and -0- absent, pursuant to the powers vested in the
Council by Section 1 (d) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
