The foregoing Resolution was passed by the Tohono O'odham Council on the 7th. day of November, 1988 at a meeting at which a quorum was present with a vote of 1,180.5 for; 147.5 against; 312.0 not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
