

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Harriet Toro for Appointment to the
National Indian Gaming Commission)


1 WHEREAS, Congress did enact, and the President did on October 17,
2 1988, sign into law, S. 555, the Indian Gaming
3 Regulatory Act, P.L. 100-497, which establishes the
4 National Indian Gaming Commission to regulate certain
5 classes of Indian gaming; and

6 WHEREAS, the Assistant Secretary of the Department of the
7 Interior, in the furtherance of tribal consultation, has
8 asked for nominations for appointment to the two
9 associate positions on the Commission.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
11 Council, on behalf of the Tohono O'Odham Nation, that it
12 does hereby nominate Harriet Toro, Chairperson of the
13 Tohono O'Odham Legislative Council, for appointment to
14 the National Indian Gaming Commission.

15 The foregoing Resolution was passed by the Tohono O'odham Council
16 on the 9th day of November, 1988 at a meeting at which a quorum
17 was present with a vote of 1,511.5 for; -0- against; 128.5 not
18 voting; and 02 absent, pursuant to the powers vested in the
19 Council by Section 1 (a) of Article VI of the Constitution of
20 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
