

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Bank Loan)

1 WHEREAS, the Sif-Oidak District Council did by Resolution No. 02-
2 88, on January 09, 1988 give their support and approval
3 of obtaining a bank loan in the amount of \$162,000.00
4 from the First Interstate Bank of Arizona, Casa Grande;

6 WHEREAS, the purpose of the bank loan is to supplement funding to
7 the Egg Complex; and

8 WHEREAS, the Sif-Oidak District Administration is now ready to
9 process the paperwork, therefore, setting a term of six
10 (6) years, at a 2% over First Interstate Bank's going
11 rate for the six (6) year Certificate of Deposit over
12 \$100,000.00; and

22 Legislative Council does hereby authorize the Sif Oidak
23 District with the execution of the bank loan in the
24 amount of \$162,000.00 with the First Interstate Bank of
25 Arizona, Casa Grande.

26 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
27 Council does hereby accept the specimen signatures for
28 the loan expenditures.

29 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
30 Council does hereby authorize the withdrawal of
31 \$162,000.00 from the Sif-Oidak District's IIM Account.

32 The foregoing Resolution was passed by the Tohono O'odham Council
on the 9th day of November, 1988 at a meeting at which a quorum
was present with a vote of 1,640.0 for; -0- against; -0- not
voting; and 02 absent, pursuant to the powers vested in the
Council by Section 1 (d)(2) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation

1 on January 18, 1986, and approved by the Acting Deputy Assistant
2 Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
