

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Procedures for Appointment, Approval, and Replacement
of Heads of Governmental Departments)

RES. NO. 322-88

1 WHEREAS, Article VII, Section 2(e) of the Constitution of the
2 Tohono O'Odham Nation states that the Chairman shall
3 exercise the following power:

4 With the approval of the Tohono O'Odham Council, to
5 appoint the treasurer, and other officers and heads
6 of all governmental departments, who shall serve
until replaced at the request of the Chairman; and

7 WHEREAS, no head of a governmental department has been appointed
8 by the Chairman and approved by the Tohono O'Odham
9 Council as required by Article VII, Section 2(e).

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
11 Council that:

- 12 1. Under Article VII, Section 2(e), the words
13 "heads of all governmental departments" mean
14 the heads or directors of parts of tribal
government to be defined as provided in this
resolution:

2. The Nation finds that persons serving as the
"head of a governmental department" without
appointment by the Chairman and approval by the
Council are serving in an acting capacity and
are subject to Article VII, Section 2(e).

- 3. The Nation finds that the failure to follow Article VII, Section 2(e) on the Director of Education has seriously affected the working relationship between the Executive and Legislative branches and must be dealt with as soon as possible.
- 4. No later than December 5, 1988 the Chairman will submit to the Council, appointments for all directors or heads of departments and the Council will approve or disapprove them, no later than December 9, 1988.

The foregoing Resolution was passed by the Tohono O'odham Council on the 10th. day of November, 1988 at a meeting at which a quorum was present with a vote of 924.5 for; 587.5 against; 128.0 not voting; and 05 absent, pursuant to the powers vested in the Council by Section 1 (c)(2) of Article VI and Section (2)(e) of Article VII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
