

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of EPA Technical Assistance Grant)

RES. NO. 323-88

1 WHEREAS, the Environmental Protection Agency's Region 9 Office
2 has notified the Tohono O'Odham Nation that a technical
3 assistance grant has been awarded for the purpose of
4 determining the feasibility of the Nation assuming
5 primacy for the Safe Drinking Water and Water Quality
6 Acts; and

7 WHEREAS, the grant would fund a study to be conducted by the
8 Council of Energy Resources Tribes (CERT) of the
9 Nation's current and future ability for implementing a
10 primacy program; and

11 WHEREAS, CERT would present its findings and recommendations to
12 the Legislative Council and other appropriate
13 departments at the completion of the study; and

14 WHEREAS, the Nation is considering the submission of an
15 application for primacy to assume the regulatory and
16 enforcement role presently administered by EPA.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
18 Council that it hereby approves the acceptance of the
19 technical assistance grant.

20 BE IT FURTHER RESOLVED that the Public Water Systems Program will
21 act as the liaison between CERT and the appropriate
22 Tohono O'Odham Nation departments during the development
23 of the study.

24 The foregoing Resolution was passed by the Tohono O'odham Council
25 on the 10th day of November, 1988 at a meeting at which a
26 quorum was present with a vote of 1,581.5 for; -0- against;
27 58.5 not voting; and 07 absent, pursuant to the powers vested
28 in the Council by Section 1 (f) of Article VI of the
29 Constitution of the Tohono O'odham Nation, adopted by the Tohono
30 O'odham Nation on January 18, 1986, and approved by the Acting
31 Deputy Assistant Secretary - Indian Affairs (Operations) on March
32 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
