WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved the Rehabilitation and After Care Services Recontract Application; and

WHEREAS, the Tohono O'Odham Nation has requested Indian Health Services to extend our existing contract from September 30, 1988 to December 30, 1988.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the attached budget to the Rehabilitation and After Care Services Contract.

FURTHER RESOLVED by the Tohono O'Odham Legislative Council BE IT that the Chairman, Vice-Chairman and Treasurer of the Tohono O'Odham Nation are hereby authorized to negotiate and execute this contract and any amendments thereto for the duration of the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 10th. day of November , 1988 at a meeting at which a quorum was present with a vote of 1,439.0 for; 116.0 against; not voting; and 07 absent, pursuant to the powers vested 85.0 in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
