

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Training Services P.L. 99-570)

RES. NO. 326-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Training Services Program as required by P. L. 99-570
3 under P. L. 93-638 contract with Public Health, Indian
4 Services; and

5 WHEREAS, such Tribal operations has been successful and
6 beneficial to the Tohono O'Odham Nation and its people;
7 and

8 WHEREAS, the Tohono O'Odham Legislative Council has reviewed and
9 approved the Training Services recontract; and

10 WHEREAS, the Tohono O'Odham Nation has requested Indian Health
11 Services to extend our existing contract from September
12 30, 1988 to December 30, 1988.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
14 Council that it does hereby approve the attached budget
15 to the Training Services Program contract.

16 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
17 that the Chairman, Vice-Chairman and Treasurer of the
18 Tohono O'Odham Nation are hereby authorized to negotiate
19 and execute this contract and any amendments thereto for
20 the duration of the contract, provided however, that any
21 amendments affecting the funding or funding levels of
22 this contract shall be submitted for further prior
23 approval by this Council.

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 10th day of November, 1988 at a meeting at which a
27 quorum was present with a vote of 1,322.0 for; -0- against;
28 318.0 not voting; and 06 absent, pursuant to the powers vested
29 in the Council by Section 1 (f) of Article VI of the
30 Constitution of the Tohono O'odham Nation, adopted by the Tohono
31 O'odham Nation on January 18, 1986, and approved by the Acting
32 Deputy Assistant Secretary - Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
