WHEREAS, the Legislative Council has reviewed the Chairman's objections and after consideration again voted to pass Resolution No. 322-88.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby override the Chairman's veto of Resolution No. 322-88, by a vote of two-thirds (2/3) of the votes cast 939.0.

The foregoing resolution was presented to the Tohono O'Odham of December, 1988, at a Legislative Council 5th. day on the meeting at which a quorum was present and by a vote of 1,067.5 for; 340.0 against; 232.5 not voting; and 02 absent, was passed by a majority of at least two-thirds (2/3) of the votes cast and became law as provided in Section 5 of Article VII of the Constitution of the Tohono O'Odham Nation.
