

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override Veto of Resolution No. 322-88 "Procedures
for appointment, approval & replacement of
Heads of Governmental Departments)

2 WHEREAS, the Legislative Council did by Resolution No. 322-88
3 provide for procedures for appointment, approval &
4 replacement of Heads of Governmental Departments; and

5 WHEREAS, upon presentation of Resolution No. 322-88 to the
6 Chairman of the Tohono O'Odham Nation he did disapprove
7 thereof and returning it to the Council with his
8 objections in accordance with the provisions of Article
9 VII, Section 5 of the Constitution of the Tohono O'Odham
10 Nation; and

11 WHEREAS, the Legislative Council has reviewed the Chairman's
12 objections and after consideration again voted to pass
13 Resolution No. 322-88.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
15 Legislative Council does hereby override the Chairman's
16 veto of Resolution No. 322-88, by a vote of two-thirds
17 (2/3) of the votes cast 939.0.

18 The foregoing resolution was presented to the Tohono O'Odham
19 Legislative Council on the 5th day of December, 1988, at a
20 meeting at which a quorum was present and by a vote of 1,067.5
21 for; 340.0 against; 232.5 not voting; and 02 absent, was passed
22 by a majority of at least two-thirds (2/3) of the votes cast and
23 became law as provided in Section 5 of Article VII of the
24 Constitution of the Tohono O'Odham Nation.
