

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Declaration - Revolving Credit Program)

RES. NO. 331-88

1 WHEREAS, the Legislative Council of the Tohono O'Odham Nation has  
2 established the Credit and Finance Program; and

3 WHEREAS, the Credit and Finance Program has been established to  
4 provide assistance in the preparation of financial plans  
5 and budgets for proposed processing of Loan and Grant  
6 applications, provide or arrange for financial  
7 management counseling on current endeavors financed with  
8 Credit and Grants, and other related activities; and

9 WHEREAS, a Declaration must be enacted to ascertain agreement of  
10 administrative policy between the Nation and the Credit  
11 and Finance Program and between the Nation and the  
12 Phoenix Area Office of the BIA Credit Office; and

13 WHEREAS, the Declaration established the formation of the Credit  
14 Committee, which has the authority to approve/disapprove  
15 all loan applications.

16 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of  
17 the Tohono O'Odham Nation hereby accepts and implements  
18 the "Declaration of Policies and Plan of Operations-  
19 Nation's Revolving Credit Program-Tohono O'Odham Nation"  
20 (attached).

21 BE IT FURTHER RESOLVED that the Legislative Council directs the  
22 Chairman of the Tohono O'Odham Nation to appoint three  
23 (3) members for the Credit Committee, as so stated in  
24 Section 6- Credit Committee, in the above stated  
25 Declaration.

26 The foregoing Resolution was passed by the Tohono O'odham Council  
27 on the 5th. day of December, 1988 at a meeting at which a quorum  
28 was present with a vote of 1,640.0 for; -0- against; -0- not  
29 voting; and 02 absent, pursuant to the powers vested in the  
30 Council by Section 1 (d)(2)(3) of Article VI of the Constitution  
31 of the Tohono O'odham Nation, adopted by the Tohono O'odham  
32 Nation on January 18, 1986, and approved by the Acting Deputy  
Assistant Secretary - Indian Affairs (Operations) on March 6,  
1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
Stat. 984).
