

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adoption into the Tohono O'Odham Nation)

RES. NO. 335-88

1 WHEREAS, FLORES, Carlos; CELAYA-ZEPEDA, Raul has made application
2 for adoption in the Tohono O'Odham Nation pursuant to
3 Section 2 of Article II of the Constitution of the
4 Tohono O'Odham Nation; and

5 WHEREAS, the Enrollment Committee has reviewed their respective
6 applications, and has made a final determination that
7 they are 1/2 degree or more of Papago-Tohono O'Odham
8 Indian blood, and have made a recommendation to the
9 Tohono O'Odham Council that their applications be
10 approved, all in accordance with the provisions of the
11 Enrollment Ordinance; and

12 WHEREAS, the Tohono O'Odham Council has reviewed the
13 recommendation of the Enrollment Committee and the
14 evidence submitted in support of the individual
15 applications.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that
17 the applications for adoption filed by:

20 are hereby approved and they are hereby adopted into
21 membership of the Tohono O'Odham Nation.

23 Council on the 6th. day of December, 1988, at a meeting at which
24 a quorum was present with a vote of 1,144.5 for; -0- against;
25 495.5 not voting; and 01 absent; pursuant to the powers vested in
26 the Council by Section 2 of Article II and Article VI Section 1
27 (h) of the Constitution of the Tohono O'Odham Nation, adopted by
28 the Tohono O'Odham Nation on January 18, 1986, and approved by
29 the Acting Deputy Assistant Secretary - Indian Affairs
30 (Operations) on March 6, 1986, pursuant to Section 16 of the Act
31 of June 18, 1934 (48 Stat. 984).
