9 The foregoing resolution was passed by the Tohono O'odham
10 Council on the 6th. day of December, 1988, at a meeting at which
11 a quorum was present with a vote of 1,143.0 for; 438.5 against;
12 58.5 not voting; and 01 absent; pursuant to the powers vested in
13 the Council by Section 3 of Article II and Article VI Section 1
14 (h) of the Constitution of the Tohono O'odham Nation on January
15 18, 1986, and approved by the Acting Deputy Assistant Secretary-
16 Indian Affairs (Operations) on March 6, 1986, pursuant to
17 Section 16 of the Act of June 18, 1934 (48 Stat. 984).


