

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointment of the Tohono O'Odham Nation's
638 Task Force)

RES. NO. 337-88

1 WHEREAS, P. L. 93-638 Indian Self-Determination and Education
2 Assistance Act of 1975 has been amended; and

3 WHEREAS, the Tohono O'Odham Nation has contracted and
4 administered contracts under this legislation since its
5 inception; and

6 WHEREAS, the amendment requires the development of regulations to
7 implement this amended legislation; and

8 WHEREAS, it is important that the Tohono O'Odham Nation
9 participate in this process; and

10 WHEREAS, the Tohono O'Odham Nation does have persons capable of
11 offering expert advice in what should be considered in
12 the regulations.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
14 Legislative Council does hereby appoint a Core Group of
15 persons as the Tohono O'Odham Nation's 638 Task Force to
16 represent the interest of the Nation in authoring the
17 638 regulations consisting of the following:

- 18 1. Enos Francisco, Jr., Chairman-Tohono O'Odham Nation
- 19 2. Harriet Toro, Chairperson-Tohono O'Odham Legislative
20 Council
- 21 3. Hilda Manuel, Chief Judge-Tohono O'Odham Judiciary
- 22 4. Rosita Ruiz, Tohono O'Odham Legislative Council
- 23 5. Ed Hansen, Director-Tohono O'Odham Health Department
- 24 6. William Strickland, Tribal Attorney-Tohono O'Odham
25 Nation

25 BE IT FURTHER RESOLVED that Rosita Ruiz is appointed Chairperson
26 of the 638 Task Force.

27 BE IT FURTHER RESOLVED that the duration of the Tohono O'Odham
28 Nation 638 Task Force will be ten (10) months which will
29 be the period at which time the final regulations will
30 be in its final form to be implemented, unless such term
31 is extended by the Tohono O'Odham Legislative Council.

1 The foregoing Resolution was passed by the Tohono O'odham Council
2 on the 6th. day of December, 1988 at a meeting at which a quorum
3 was present with a vote of 1,185.0 for; 296.0 against; 159.0
4 not voting; and 01 absent, pursuant to the powers vested in the
5 Council by Section 1 (b) of Article VI of the Constitution of
6 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
7 on January 18, 1986, and approved by the Acting Deputy Assistant
8 Secretary - Indian Affairs (Operations) on March 6, 1986,
9 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
10 984).
