

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Increase Social Service Funding for a Protective Service
Unit for Children and Adults)

RES. NO. 33-88

1 WHEREAS, the Tohono O'odham Nation first contracted for the
2 Bureau of Indian Affairs Social Service Program under
3 Public Law 93-638 in Fiscal year 1984; and

4 WHEREAS, the Social Service contract states that the Tohono
5 O'odham Nation will provide services according to the
6 federal regulations in 25 CFR Part 20; and

7 WHEREAS, the 25 CFR 20:24 states that family and community
8 services shall be provided which includes but is not
9 limited to protective services for children and adults;
10 and

11 WHEREAS, child abuse and neglect are serious problems in the
12 Tohono O'odham Nation and has increased from 30
13 referrals in FY - 84 to 288 referrals in FY - 87, an
14 increase of 317% in three years; and

15 WHEREAS, the Tohono O'odham Nation also recognizes the increase
16 in elderly abuse and neglect; and

17 WHEREAS, this increase in the number of abused and neglected
18 children and adults has resulted in a lack of services
19 to treat them due to the lack of funding for the
20 Protective Services Unit; and

21 WHEREAS, the Tohono O'odham Nation is responding to this need
22 through redesigning the Human Service Department to add
23 a Protective Service Unit for Adults and Children; and

24 WHEREAS, the current administrative budget is insufficient to add
25 a Protective Service Unit.

26 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legis-
27 lative Council is requesting an increase of \$100,000.00
28 to the administrative funding of the social service
29 program for a Protective Service Unit for children ad
30 adults.

1 The foregoing resolution was passed by the Tohono O'odham Council
2 on the 19th day of February, 1988, at a meeting at which a quorum
3 was present with a vote of 1,640.0 for; -0- against; -0- not
4 voting; and 01 absent, pursuant to the powers vested in the
5 Council by Section 1(c)(2) & (f) of Article IV of the Consti-
6 tution of the Tohono O'odham Nation, adopted by the Tohono
7 O'odham Nation on January 18, 1986, and approved by the Acting
8 Deputy Assistant Secretary - Indian Affairs (Operations) on March
9 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
10 Stat. 984).
