

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Proposal Abstract to March of Dimes
for Prenatal Education)

RES. NO. 340-88

1 WHEREAS, the Tohono O'Odham Legislative Council is desirous to
2 protect and ensure the well-being of pregnant O'Odham
3 women, their children and families; and

4 WHEREAS, the Tohono O'Odham Legislative Council recognizes the
5 importance of educating the O'Odham women in the
6 importance of early prenatal care; and

7 WHEREAS, the Tohono O'Odham Legislative Council recognizes that
8 prenatal care enhances pregnancy outcome; and

9 WHEREAS, the March of Dimes Foundation funds programs that
10 promote perinatal health and prevention of birth
11 defects.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council to apply for a March of Dimes Foundation Grant
14 in order to improve the access to, utilization of, and
15 quality of, prenatal care of O'Odham women and their
16 infants.

18 The foregoing Resolution was passed by the Tohono O'odham Council
19 on the 6th. day of December, 1988 at a meeting at which a quorum
20 was present with a vote of 1,640.0 for; -0- against; -0- not
21 voting; and 01 absent, pursuant to the powers vested in the
22 Council by Section 1 (f) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).


