- WHEREAS, Ms. Juanita Parvello, a fully qualified member and employee, was appointed to assume the duties of Chief Financial Officer; and
- whereas, the Chairman of the Tohono O'Odham Nation has not appointed a Treasurer of the Nation within the foregoing period of 90 days, and it is necessary to extend the term of appointment of the Chief Financial Officer pending such appointment.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative

 Council that the appointment of Ms. Juanita Parvello to
 the position of Chief Financial Officer is hereby
 extended indefinitely and until the Chairman of the
 Nation appoints a Treasurer in accordance with the
 provisions of Section 2(c) of Article VII of the
 Constitution in order to assume the authority and
 responsibilities of the Chief Financial Officer.

The foregoing Resolution was passed by the Tohono O'odham Council on the 8th. day of December , 1988 at a meeting at which a quorum was present with a vote of 1,523.0 for; -0- against; -0- not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
