

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Extending the appointment of Ms. Juanita Parvello  
as Chief Financial Officer )

RES. NO. 347-88

1 WHEREAS, in order to provide for the security of the Nation's  
2 financial management system, the Tohono O'odham  
3 Legislative Council, acting under the authority  
4 contained in Article VI, Section 1. (b) of the  
5 Constitution of the Tohono O'odham Nation, established  
6 the position of Chief Financial Officer, for an interim  
7 period of 90 days, subject to extensions; and

8 WHEREAS, Ms. Juanita Parvello, a fully qualified member and  
9 employee, was appointed to assume the duties of Chief  
10 Financial Officer; and

11 WHEREAS, the Chairman of the Tohono O'odham Nation has not  
12 appointed a Treasurer of the Nation within the foregoing  
13 period of 90 days, and it is necessary to extend the  
14 term of appointment of the Chief Financial Officer  
15 pending such appointment.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
17 Council that the appointment of Ms. Juanita Parvello to  
18 the position of Chief Financial Officer is hereby  
19 extended indefinitely and until the Chairman of the  
20 Nation appoints a Treasurer in accordance with the  
21 provisions of Section 2(c) of Article VII of the  
22 Constitution in order to assume the authority and  
23 responsibilities of the Chief Financial Officer.

24 The foregoing Resolution was passed by the Tohono O'odham Council  
25 on the 8th day of December, 1988 at a meeting at which a quorum  
26 was present with a vote of 1,523.0 for; -0- against; -0- not  
27 voting; and 03 absent, pursuant to the powers vested in the  
28 Council by Section 1 (b) of Article VI of the Constitution of  
29 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
