

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Endorsement of San Xavier District Council's Cooperative
Education Training Position)

RES. NO. 350-88

1 WHEREAS, by Resolution No. 11-88-02, the San Xavier District
2 Council did establish a cooperative education training
3 position with the legal firm of Barassi & Burris, P.C.;
4 and

5 WHEREAS, the San Xavier District Council by enactment of
6 Resolution No. 11-88-04 did amend its FY 1989 budget to
7 include additional funds to support the San Xavier
8 District Cooperative Education training position from
9 its Papago Bingo revenues; and

10 WHEREAS, the San Xavier District Council did direct, by
11 Resolution No. 11-88-03, the San Xavier District
12 administration to initiate a contractual arrangement
13 between the San Xavier District and Mr. Authur Bailey
14 for a one year period; and

15 WHEREAS, the establishment of the cooperative educational/
16 training will serve a dual purpose of developing San
17 Xavier District Human Resources and ensuring that the
18 San Xavier District benefit from the gained expertise by
19 creating a commitment for post-educational/training
20 employment within the San Xavier District
21 administration; and

22 WHEREAS, candidates for the San Xavier Cooperative Education
23 training programs will be all qualified District
24 members.

25 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
26 Council that it approves an increase of \$7,000.00 to the
27 San Xavier District FY 1989 budget for the purpose of
28 establishing its Cooperative Education Training
29 Position.

30 The foregoing Resolution was passed by the Tohono O'odham Council
31 on the 8th. day of December, 1988 at a meeting at which a quorum
32 was present with a vote of 1,640.0 for; -0- against; -0- not
voting; and 01 absent, pursuant to the powers vested in the
Council by Section 1(c) (2) & (d)(2) of Article VI of the
Constitution of the Tohono O'odham Nation, adopted by the Tohono

O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
