WHEREAS, the Council has appropriated funds in the amount of \$250,000.00 in FY 89 budget for the financing of Entrepreneurs of the Tohono O'Odham Nation.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council release for deposit that sum of \$250,000.00 to the official depository, as stated in the "Declaration of Policies and Plan of Operations-Nation's Revolving Credit Program-Tohono O'Odham Nation", Section 13.

BE IT FURTHER RESOLVED that the Legislative Council authorize the Chairman to make loan application to the Credit Office, Phoenix Area Office-BIA, for the sum of \$250,000.00 matching funds to be deposited to the official depository, as stated in Section 13 of the Declaration.

The foregoing Resolution was passed by the Tohono O'odham Council on the 8th. day of December , 1988 at a meeting at which a quorum was present with a vote of 1,577.0 for; -0- against; 63.0 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1 (d)(2)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
