

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Payment of Vi-ikam Doag Industries
FICA Payments)

RES. NO. 352-88

1 WHEREAS, Vi-ikam Doag Industries is a public corporation owned by
2 the San Lucy District and did in the past incur Social
3 Security and Federal and State Tax Withholding
4 liabilities as an employer starting in the 1987 tax year
5 and there is presently due therefor the sum of
6 \$10,908.58, including penalties and interest thereon;
7 and

8 WHEREAS, the foregoing liabilities were incurred for the overall
9 benefit of the San Lucy District, and the District
10 Council has requested that the Legislative Council
11 appropriate said sum from funds available to the
12 District pursuant to P. L. 99-503.

13 NOW, THEREFORE, BE IT RESOLVED that the sum of \$10,908.58 is
14 hereby appropriated from funds available to the San Lucy
15 District pursuant to P. L. 99-503 to cover outstanding
16 liabilities of Vi-ikam Doag Industries for unpaid Social
17 Security and Withholding Taxes, plus penalties and
18 interest thereon.

19 BE IT FURTHER RESOLVED that the payment to the Internal Revenue
20 Service be administered by the Tohono O'Odham Nation's
21 Accounting Office.

23 The foregoing Resolution was passed by the Tohono O'odham Council
24 on the 8th. day of December, 1988 at a meeting at which a quorum
25 was present with a vote of 769.5 for; 312.0 against; 558.5 not
26 voting; and 02 absent, pursuant to the powers vested in the
27 Council by Section 1 (d)(2) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
