(Override Veto of Resolution No. 347-88, "Extending the
Appointment of Ms. Juanita Parvello as Chief Financial Officer)

2 WHEREAS, the Legislative Council did by Resolution No. 347-88,
3 extend the Appointment of Ms. Juanita Parvello as Chief
4 Financial Officer; and

5 WHEREAS, upon presentation of Resolution No. 347-88 to the
6 Chairman of the Tohono O'Odham Nation he did disapprove
7 thereof and returned it to the Council with his
8 objections in accordance with the provisions of Article
9 VII, Section 5 of the Constitution of the Tohono O'Odham
10 Nation; and

11 WHEREAS, the Legislative Council has reviewed the Chairman's
12 objections and after consideration again voted to pass
13 Resolution No. 347-88.


14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legisla-
15 tive Council does hereby override the Chairman's veto of
16 Resolution No. 347-88, by a vote of two-thirds (2/3) of
17 the votes cast 1,065.0.

18 The foregoing resolution was presented to the Tohono O'Odham
19 Legislative Council on the 16th. day of December, 1988, at a
20 meeting at which a quorum was present and by a vote of 1,597.5
21 for; -0- against; 42.5 not voting; and -0- absent, was passed by
22 a majority of at least two-thirds (2/3) of the votes cast and
23 became law as provided in Section 5 of Article VII of the
24 Constitution of the Tohono O'Odham Nation.
