

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Tohono O'odham Psychological Services Tribal Budget)

RES. NO. 356-88

1 WHEREAS, the Tohono O'odham Nation has continuously operated a
2 psychological services program since 1969; and

3 WHEREAS, the Indian Health Services, in August 1988, did withdraw
4 funding for the operation of the Tohono O'odham Psycho-
5 logical Service Program under P.L. 93-638 contract,
6 #249-88-0010; and

7 WHEREAS, the Tohono O'odham Nation feels that this contract
8 recision was inappropriate and without substantial
9 merit and subsequent to the recision has filed an
10 appeal on the record; and

11 WHEREAS, the Tohono O'odham Nation has continued to operate a
12 psychological service program in the interest of the
13 O'odham and will continue to do so until a new contract
14 can be negotiated with the Indian Health Service (IHS)
15 and the issues under appeal are resolved.

16 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of
17 the Tohono O'odham Nation does appropriate One Hundred
18 Seventy-Seven Thousand, Three Hundred Forty-Seven
19 Dollars (\$177,347.00) from the Nation's General Fund for
20 the operation of the Nation's Psychological Service
21 Program from the period of October 1, 1988 through
22 September 30, 1989.

23 BE IT FURTHER RESOLVED that the Legislative Council of the Tohono
24 O'odham Nation authorize the use of Sixty-Three
25 Thousand Dollars (\$63,000.00) of the General Fund to
26 support the legal fees and miscellaneous expenses
27 related to the appeal on the record.

28 BE IT FURTHER RESOLVED that the funds appropriated for program
29 operations from the general fund will be terminated upon
30 award of a P.L. 93-638 contract for program operations.

31 BE IT FURTHER RESOLVED that if the Tohono O'odham Nation prevails
32 in its appeal on the record and is reimbursed for
operational and legal expenses incurred subsequent to

the recision of Contract No. #249-88-0010, such reimbursement will be returned to the Nation's General Fund.

The foregoing Resolution was passed by the Tohono O'odham Council on the 16th day of December, 1988 at a meeting at which a quorum was present with a vote of 781.5 for; 492.5 against; 366.0 not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1(d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


