

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the National Indian Health Board Discussion Paper
on issues related to SURAM/PL 93-638 Contracting)

RES. NO. 35-88

1 WHEREAS, the Tohono O'Odham Nation is committed to the maximum
2 availability of health care services to its community
3 members; and

4 WHEREAS, the Tohono O'Odham Nation is desirous of efficient
5 management and administration of the health care service
6 resources available to the Nation; and

7 WHEREAS, the National Indian Health Board did convene a group of
8 Tribal Representatives from across the nation to develop
9 discussion points on issues related to SURAM (Service
10 Unit Resource Allocation Methodology) and other matters
11 related to contracting under P. L. 93-638, the Indian
12 Self-Determination and Education Assistance Act of 1975,
13 which affect the administration and management of health
14 care services; and

15 WHEREAS, staff of the Tohono O'Odham Health Department did
16 participate in this activity and did contribute to the
17 authorship of a discussion paper which addresses
18 numerous germane issues.

19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
20 Legislative Council does endorse the National Indian
21 Health Board Discussion Paper on issues related to
22 SURAM/ P. L. 93-638 contracting, and seeks the support
23 of the Arizona Congressional Delegation.

24 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
25 Council does support the appropriate addressal of
26 identified issues to the satisfaction of collective
27 Indian Nations.

29 The foregoing resolution was passed by the Tohono O'odham Council
30 on the 19th day of February, 1988, at a meeting at which a quorum
31 was present with a vote of 1,407.5 for; -0- against; 232.5 not
32 voting; and 02 absent, pursuant to the powers vested in the
Council by Section 1(c)(2) & (f) of Article IV of the Consti-
tution of the Tohono O'odham Nation, adopted by the Tohono
O'odham Nation on January 18, 1986, and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).




