

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the Alternate Resource Task Group Report-Study
Results and Recommendations)

RES. NO. 37-88

1 WHEREAS, the Tohono O'odham Nation supports in principle the
2 allocation of limited health care fiscal resources
3 through a standard consistently applied, allocation
4 methodology; and

5 WHEREAS, the Indian Health Service is in the process of
6 incrementally introducing revision of the historical
7 allocation methodology called Area Resource Allocation
8 (ARAM)/Service Unit Resource Allocation Methodology
9 (SURAM); and

10 WHEREAS, the Indian Health Service has established task groups to
11 address key areas of Tribal concern in the ARAM/SURAM
12 methodology; and

13 WHEREAS, staff of the Tohono O'Odham Health Department did
14 participate on such task group addressing the
15 consideration of alternative resources and contributed
16 to the authorship of a study report and recommendation.

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
18 Legislative Council does hereby seek the support of the
19 Arizona Congressional Delegation that Medicare be
20 considered an alternate resource when determining the
21 IHS allocation to Service Units or Tribal Operations.

22 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
23 Council does endorse this resolution and encourages IHS
24 adoption of the recommendations developed by the
25 Alternate Resources Task Group in Seattle during August
26 1987.

27 The foregoing resolution was passed by the Tohono O'odham Council
28 on the 19th day of February, 1988, at a meeting at which a quorum
29 was present with a vote of 1,317.0 for; 63.0 against; 260.0 not
30 voting; and 01 absent, pursuant to the powers vested in the
31 Council by Section (1)(c) & (f) of Article IV of the Constitution
32 of the Tohono O'odham Nation, adopted by the Tohono O'odham
Nation on January 18, 1986, and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
