whereas, the Inter Tribal Council of Arizona, Inc. (ITCA) has requested that a special investigation committee be established by the Senate Select Committee on Indian Affairs in order to conduct an on-site investigation of the Office of the Education Program Administrator for the BIA - Phoenix Area Office, Phoenix Indian High and Sherman Indian High School, regarding compliance with minimum academic standards for the basic education of Indian children and national criteria for dormitory situations prescribed under the provisions of CFR 25 Part 36, as authorized by P.L. 95-561; and

WHEREAS, the Tohono O'odham Council fully concurs with the request for such on-site oversight investigation at the Phoenix Area level, with the request, however, that it be expanded to include a similar compliance investigation at the Papago Agency level.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does hereby support the request by the ITCA for an on-site investigation by a subcommittee of the Senate Select Committee of the Office of the Education Program Administrator for the BIA-Phoenix Area Office.

BE IT FURTHER RESOLVED that the Council does hereby request that such investigation be expanded to include a similar compliance investigation at the Papago Agency level.

The foregoing resolution was passed by the Tohono O'odham Council on the 19th day of February, 1988, at a meeting at which a quorum was present with a vote of 1,577.0 for; -0- against; 63.0 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1 (j) of Article IV of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
