

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Requesting Investigation of Area and Agency Offices of
Education by Subcommittee of Senate Select Committee)

RES. NO. 38-88

1 WHEREAS, the Inter Tribal Council of Arizona, Inc. (ITCA) has
2 requested that a special investigation committee be
3 established by the Senate Select Committee on Indian
4 Affairs in order to conduct an on-site investigation of
5 the Office of the Education Program Administrator for
6 the BIA - Phoenix Area Office, Phoenix Indian High and
7 Sherman Indian High School, regarding compliance with
8 minimum academic standards for the basic education of
9 Indian children and national criteria for dormitory
10 situations prescribed under the provisions of CFR 25
11 Part 36, as authorized by P.L. 95-561; and

12 WHEREAS, the Tohono O'odham Council fully concurs with the
13 request for such on-site oversight investigation at the
14 Phoenix Area level, with the request, however, that it
15 be expanded to include a similar compliance
16 investigation at the Papago Agency level.

17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that
18 it does hereby support the request by the ITCA for an
19 on-site investigation by a subcommittee of the Senate
20 Select Committee of the Office of the Education Program
21 Administrator for the BIA-Phoenix Area Office.

22 BE IT FURTHER RESOLVED that the Council does hereby request that
23 such investigation be expanded to include a similar
24 compliance investigation at the Papago Agency level.

25 The foregoing resolution was passed by the Tohono O'odham Council
26 on the 19th day of February, 1988, at a meeting at which a quorum
27 was present with a vote of 1,577.0 for; -0- against; 63.0 not
28 voting; and 01 absent, pursuant to the powers vested in the
29 Council by Section 1 (j) of Article IV of the Constitution of
30 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
