

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Application for Grant Funds for
Parenting Skills Training)

RES. NO. 48-88

1 WHEREAS, the Tohono O'Odham Human Service Department has been
2 delegated the responsibility for planning, developing
3 and providing social services for the general welfare of
4 families and children; and

5 WHEREAS, the provision of social services for children and
6 families includes preventive, interventive and treatment
7 services; and

8 WHEREAS, providing parenting skills training is an interventive
9 social service; and

10 WHEREAS, the Arizona Department of Economic Security has made
11 funds available to Indian Tribes for the development and
12 implementation of child abuse and neglect prevention
13 projects; and

14 WHEREAS, Parenting Skills Training is a preventive service for
15 child abuse and neglect; and

16 WHEREAS, the Tohono O'Odham Human Service Department has
17 successfully provided Parenting Skills Training since
18 1986; and

19 WHEREAS, there continues to be a need for Parenting Skills
20 Training as a preventive service for child abuse and
21 neglect.

22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
23 Council that it does hereby approve of the application
24 for grant funds from the Arizona Department of Economic
25 Security for the provision of a Parenting Skills
26 Training Program by the Tohono O'Odham Human Service
27 Department.

28 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
29 Council will not fund or operate programs from which
30 grants are requested herewith which have not been
31 negotiated and executed by the Arizona Department of
32 Economic Security prior to the start of the funding
year.

1 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
2 that it does authorize the Human Service Department to
3 apply for a Parenting Skills Training Project Funds in
4 accordance with applicable regulations and hereby
5 directs the Chairman, Vice-Chairman or Treasurer, to
6 negotiate and execute this grant and any amendments
7 thereto for the duration of the grant, provided
8 however, that any amendments affecting the funding or
9 funding levels of this grant shall be submitted for
10 further prior approval by this Council.

12 The foregoing resolution was passed by the Tohono O'odham Council
13 on the 7th day of March, 1988, at a meeting at which a quorum
14 was present with a vote of 1.640.0 for; -0- against; -0- not
15 voting; and 03 absent, pursuant to the powers vested in the
16 Council by Section 1 (f) of Article IV of the Constitution of the
17 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
18 January 18, 1986, and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986,
20 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
21 984).
