

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY '89 Title XX Grant - Child Day Care)

RES. NO. 49-88

1 WHEREAS, the Tohono O'Odham Nation has consistently supported the
2 nurturance of its young members by providing for their
3 welfare through various programs and services designed
4 to meet their special needs; and

5 WHEREAS, the Child Day Care Services Program has been
6 successfully operated through the Early Childhood
7 Division and has served many young Tohono O'Odham
8 Children; and

9 WHEREAS, the Tohono O'Odham Legislative Council is desirous of
10 continuing this program for the benefit of its young
11 members; and

12 WHEREAS, the Tohono O'Odham Nation has previously applied for
13 and received funding to operate the Child Day Care
14 Service Program from the Department of Economic
15 Security, Block Grant Administration, Title XX Day Care;
16 and

17 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
18 proposed grant and finds the same to be of benefit to
19 the Child Day Care Service Program.

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
21 Council that it does hereby approve the proposed grant
22 for Title XX Child Day Care Services.

23 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
24 Council will not fund or operate programs from which
25 grants are requested herewith which have not been
26 negotiated and executed by the Department of Economic
27 Security prior to the start of the funding year.

28 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
29 that the Chairman, Vice-Chairman and Treasurer of the
30 Tohono O'Odham Nation are hereby authorized to negotiate
31 and execute this grant and any amendments thereto for
32 the duration of this grant, provided however, that any

amendments affecting the funding or funding levels of
this grant shall be submitted for further prior approval
by this Council.

The foregoing resolution was passed by the Tohono O'odham Council
on the 7th day of March, 1988, at a meeting at which a quorum
was present with a vote of 1,640.0 for; -0- against; -0- not
voting; and 03 absent, pursuant to the powers vested in the
Council by Section 1 (f) of Article IV of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
