 Services.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed agreement has been awarded by the United Way of Tucson Agency.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Chairman, Vice-Chairman and Treasurer of the Tohono O'Odham Nation are hereby authorized to negotiate and execute this agreement and any amendments thereto for the duration of the contract, provided however, that any amendments affecting the funding or funding levels of this agreement shall be submitted for further prior approval by this Council.

The foregoing resolution was passed by the Tohono O'odham Council on the 7th. day of March, 1988, at a meeting at which a quorum was present with a vote of 1,582.0 for; 58.0 against; -0- not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article IV of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1936, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
