

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Enrollment - March)

1 WHEREAS, the Tohono O'Odham Council has reviewed the



1 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that
2 the above named applicants are eligible for enrollment
3 as members of the Tohono O'Odham Nation under Section
4 1(a) or (b) of Article II of the Constitution of the
5 Tohono O'Odham Nation, and that their applications are
6 approved, as herein above indicated.


7 BE IT FURTHER RESOLVED that the Chairman and other appropriate
8 officers of the Tohono O'Odham Nation reduce this final
9 determination in writing regarding each of the foregoing
10 applications for enrollment in accordance with Section 3
11 (c) of Article III of the Enrollment Ordinance; give
12 notice of this Council's determination in accordance
13 with Section 4 of Article III of the Enrollment
14 Ordinance; and place the names of each applicant upon
15 the membership roll of the Tohono O'Odham Nation in
16 accordance with Article V of the Enrollment Ordinance.

17 The foregoing Resolution was passed by the Tohono O'Odham Council
18 on the 7th day of March, 1988 at a meeting at which a quorum
19 was present with a vote of 1,460.0 for; -0- against; 180.0 not
20 voting; and 03 absent, pursuant to the powers vested in the
21 Council by Section 1 of Article II and of Section 1 (h) of
22 Article VI of the Constitution of the Tohono O'Odham Nation,
adopted by the Tohono O'Odham Nation on January 13, 1986 and
approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986 pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).


