2 MURRIETTA, Francisco; SINOHUE-MURRIETTA, Pedro Jr.;

3 ZEPEDA, Jesse has made application for adoption in the
4 Tohono O'Odham Nation pursuant to Section 2 of Article
5 II of the Constitution of the Tohono O'Odham Nation; and

6 WHEREAS, the Enrollment Committee has reviewed their respective
7 applications, and has made a final determination that
8 they are 1/2 degree or more of Papago-Tohono O'Odham
9 Indian blood, and have made a recommendation to the
10 Tohono O'Odham Council that their applications be
11 approved, all in accordance with the provisions of the
12 Enrollment Ordinance; and

13 WHEREAS, the Tohono O'Odham Council has reviewed the
14 recommendation of the Enrollment Committee and the
15 evidence submitted in support of the individual
16 applications.

on March 6, 1986, pursuant to Section 16 of the Act of June 13,
1934 (48 Stat. 984).
