11 Council on the 7th. day of March, 1988, at a meeting at which a
12 quorum was present with a vote of 987.0 for; 290.5 against; 362.5
13 not voting; and 03 absent; pursuant to the powers vested in the
14 Council by Section 3 of Article II and Article VI Section 1 (h)
of the Constitution of the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary-
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
