(Accepting Resignation of Judge Phyllis Cachora)

1 WHEREAS, the Legislative Council received a copy of the
2 resignation letter from Tribal Judge Phyllis Cachora
3 dated January 14, 1988; and

4 WHEREAS, the Judiciary Committee has reviewed the resignation
5 letter and recommends to the Legislative Council the
6 acceptance of her request to resign as a Tribal Judge
7 effective January 28, 1988.

8 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that
9 the resignation letter of Tribal Judge, Phyllis Cachora,
10 is hereby accepted.

11 BE IT FURTHER RESOLVED that the resignation be effective January
12 28, 1988.

13 The foregoing resolution was passed by the Tohono O'odham Council
14 on the 8th day of March, 1988, at a meeting at which a quorum
15 was present with a vote of 1,258.0 for; 52.5 against; 329.5 not
16 voting; and 03 absent, pursuant to the powers vested in the
17 Council by Section 1 (b) of Article VI of the Constitution of
18 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).


