(Referring FY '87 Budget Close Out to the  
Budget & Finance Committee for Adjustment)

LEGIS. ORDER NO. 59-88

1 WHEREAS, the Budget & Finance Committee presented to the  
2 Legislative Council a report on the Close-Out of the FY  
3 '87 budgets for Council action; and

4 WHEREAS, the report did not reflect any revenue income from  
5 Noranda or Papago Chemicals Inc. even though payments  
6 were made during Fiscal Year 1987; and

7 WHEREAS, the Council agreed that the report should include  
8 payments made by Noranda and Papago Chemicals Inc. as  
9 part of the actual revenues even though the deposits  
10 were placed in a restricted account.


11 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that  
12 the report shall reflect Noranda and Papago Chemicals  
13 Inc. payments as actual revenues.

16 Council on the 8th day of March, 1988, at a meeting at which a  
17 quorum was present with a vote of 1,577.0 for; -0- against; 63.0  
18 not voting; and 03 absent, pursuant to the powers vested in the  
19 Council by Section 1 (a) of Article VI of the Constitution of  
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
