

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization of Water Resource Committee Members
to meet with the Bureau of Reclamation)

RES. NO. 61-88

1 WHEREAS, the Tohono O'Odham Legislative Council did receive a
2 report from the Water Resource Committee regarding the
3 Cost Percentage originally approved by the Tohono
4 O'Odham Legislative Council with the Bureau of
5 Reclamation; and

6 WHEREAS, there has been a meeting scheduled to meet with the
7 Bureau of Reclamation officials in Washington, D.C.
8 during the week of March 14-18, 1988; and

9 WHEREAS, it is important that the Tohono O'Odham Nation be
10 involved in such meeting.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
12 Legislative Council hereby authorizes Tony Felix and
13 Edward Manuel of the Water Resource Committee to meet
14 with the Bureau of Reclamation Officials in order to
15 represent the Tohono O'Odham Nation, along with Enos
16 Francisco, Jr., Chairman; William Strickland, Attorney;
17 Marvin Warner, Water Coordinator; and Gene Franzoy,
18 Engineer Consultant.

19 BE IT FURTHER RESOLVED that the expenses of Tony Felix and Edward
20 Manuel shall be paid out of the Water Trust Fund.

22 The foregoing resolution was passed by the Tohono O'odham Council
23 on the 9th day of March, 1988, at a meeting at which a quorum
24 was present with a vote of 1,178.5 for; 244.0 against; 217.5
25 not voting; and 02 absent, pursuant to the powers vested in the
26 Council by Section 1 (b)(d)(2)(3) & (f) of Article VI of the
27 Constitution of the Tohono O'odham Nation, adopted by the Tohono
28 O'odham Nation on January 18, 1986, and approved by the Acting
29 Deputy Assistant Secretary - Indian Affairs (Operations) on March
30 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
31 Stat. 984).
