BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and the 12 Treasurer of the Tohono O'Odham Nation are hereby 13 authorized to negotiate and execute the contract and any 14 amendments thereto for the duration of the contract, 15 provided however, that any amendments affecting the 16 funding or funding levels of the contract shall be 17 submitted for further prior approval by this Council. 18

19 The foregoing resolution was passed by the Tohono O'odham Council on the <u>9th</u> day of <u>March</u>, <u>1988</u>, at a meeting at which a quorum was present with a vote of <u>1,417.5</u> for; <u>121.5</u> against; <u>101.0</u> not voting; and <u>02</u> absent, pursuant to the powers vested in the Council by Section <u>1</u> (f) of Article VI of the Constitution of $\mathbf{20}$ 21of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation 22on January 18, 1986, and approved by the Acting Deputy Assistant Indian Affairs (Operations) on March 6, 1986, Secretary -23pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 24
