

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Directing the Water Resource Committee, Sif  
Oidak District Council & Tribal Attorney to  
meet with the City of Tucson)

RES. NO. 63-88

1 WHEREAS, the Legislative Council on March 10, 1988, were provided  
2 a presentation on the proposed Chui Chu Settlement Bill  
3 and the options supported by the Sif Oidak District; and

4 WHEREAS, the Water Resource Committee and the Sif Oidak District  
5 Council have been reviewing the Chui Chu Settlement Bill  
6 and have also had public hearings to get input from  
7 District members; and

8 WHEREAS, the Sif Oidak District Council met on February 16, 1988,  
9 to finalize the options available under the Chui Chu  
10 Water Settlement Bill by enacting Resolution No. 06-88;  
11 and

12 WHEREAS, the District Council believes that it would be in their  
13 best interest to support and adopt Resolution No. 06-88,  
14 which certifies Option B of the Sif Oidak District  
15 Council.

16 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council  
17 hereby authorizes the Water Resource Committee, Sif  
18 Oidak District Council, and the Tribal Attorney to meet  
19 with the City of Tucson to begin discussion on Option B  
20 supported by the Sif Oidak District Council per  
21 Resolution No. 06-88.

22 BE IT FURTHER RESOLVED that if the Sif Oidak District Council's  
23 Option B is unacceptable by the City of Tucson the  
24 authorized parties shall proceed with the Tribal  
25 Attorney's draft Option B.

27 The foregoing resolution was passed by the Tohono O'odham Council  
28 on the 10th day of March, 1988, at a meeting at which a quorum  
29 was present with a vote of 1,429.5 for; 84.5 against; 117.0 not  
30 voting; and 02 absent, pursuant to the powers vested in the  
31 Council by Section 1 (f) of Article VI of the Constitution of  
32 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
984).
