IT RESOLVED that BE NOW, the Water hereby approve does Council Legislative 9B Committee's recommendation of the Resource Alternative as attached and does authorize the Chairman of the Nation or other appropriate Officers of the Nation to direct the Nation's Consultants and the Water Project Office Staff to revise the draft San Xavier Development Plan accordingly.

BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative
Council authorizes the Nation's Chairman or other
appropriate Officers to direct the Water Project Staff
to research the utilization of unused water under the
proposed Schuk Toak and San Xavier Farm Project as
provided under the Southern Arizona Water Rights
Settlement Act (SAWRSA).

The foregoing resolution was passed by the Tohono O'odham Council on the 31st. day of March 1988, at a meeting at which a quorum was present with a vote of 1,100.0 for; 242.5 against; 297.5 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1 of Article XVI and Section 2 of Article XVII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
