

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Enrollment - April)

1 WHEREAS, the Tohono O'Odham Council has reviewed the



13 1(a) or (b) of Article II of the Constitution of the
14 Tohono O'Odham Nation, and that their applications are
15 approved, as herein above indicated.


16 BE IT FURTHER RESOLVED that the Chairman and other appropriate
17 officers of the Tohono O'Odham Nation reduce this final
18 determination in writing regarding each of the foregoing
19 applications for enrollment in accordance with Section 3
20 (c) of Article III of the Enrollment Ordinance; give
21 notice of this Council's determination in accordance
22 with Section 4 of Article III of the Enrollment
23 Ordinance; and place the names of each applicant upon
24 the membership roll of the Tohono O'Odham Nation in
25 accordance with Article V of the Enrollment Ordinance.

26 The foregoing Resolution was passed by the Tohono O'Odham Council
27 on the 4th day of April, 1988 at a meeting at which a quorum
28 was present with a vote of 1,402.0 for; 58.0 against; 180.0 not
29 voting; and 02 absent, pursuant to the powers vested in the
30 Council by Section 1 of Article II and of Section 1 (h) of
31 Article VI of the Constitution of the Tohono O'Odham Nation,
32 adopted by the Tohono O'Odham Nation on January 18, 1986 and
approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986 pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
