The foregoing resolution was passed by the Tohono O'odham Council on the 4th. day of April, 1988, at a meeting at which a quorum was present with a vote of 1,402.0 for; -0- against; 238.0 not voting; and 02 absent; pursuant to the powers vested in the Council by Section 2 of Article II and Article VI Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
