

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Ceasing discussion on resolution regarding the Hia-Ced  
O'Odham Descendants & referring to the Enrollment Committee)

LEGIS. ORDER NO. 78-88

1 WHEREAS, the Tohono O'Odham Legislative Council reviewed San Lucy  
2 District Council Resolution No. 03-08-88 (Support of the  
3 Hia-Ced O'Odham Descendants) which supports the Mendivil  
4 Family to be added to the official Census Roll of the  
5 Tohono O'Odham Nation; and

6 WHEREAS, the Council did discuss the issue and felt it should  
7 follow the established process which is to have the  
8 Enrollment Committee review the names before they are  
9 presented to the Tohono O'Odham Legislative Council.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
11 Council to discontinue their discussion on the Hia-Ced  
12 O'Odham Descendants resolution and refer the issue back  
13 to the Enrollment Committee to follow through with the  
14 established process.

15 The foregoing Legislative Order was passed by the Tohono O'odham  
16 Council on the 5th. day of April, 1988 at a meeting at which a  
17 quorum was present with a vote of 1,417.5 for; 101.0 against;  
18 121.5 not voting; and 01 absent, pursuant to the powers vested  
19 in the Council by Section 1 (b) of Article VI of the Constitution  
20 of the Tohono O'odham Nation, adopted by the Tohono O'odham  
21 Nation on January 18, 1986, and approved by the Acting Deputy  
22 Assistant Secretary - Indian Affairs (Operations) on March 6,  
23 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
24 Stat. 984).
