

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Referring Tohono O'odham Firefighters Budget to the
Budget & Finance and Natural Resources Committee)

LEGIS. ORDER NO. 91-88

1 WHEREAS, the Tohono O'odham Legislative Council reviewed the
2 budget presented by the T.E.R.O. Director in behalf of
3 the Tohono O'odham Nation "Firehawks" Firefighters; and

4 WHEREAS, the Budget & Finance Committee who reviewed the budget
5 brought to the Legislative Council attention that the
6 budget presented has a different amount from the one
7 reviewed and approved; and

8 WHEREAS, the budget should be referred back to the Budget &
9 Finance and Natural Resources Committee for further
10 review.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
12 Council that the Tohono O'odham "Firehawks"
13 Firefighters's Budget be referred back to the Budget &
14 Finance and Natural Resources Committee for further
15 review.

16 BE IT FURTHER RESOLVED that the budget be brought back before the
17 end of this Legislative Session.

19 The foregoing Legislative Order was passed by the Tohono O'odham
20 Council on the 6th day of April, 1988 at a meeting at which a
21 quorum was present with a vote of 1,175.0 for; 284.0 against;
22 181.0 not voting; and 01 absent, pursuant to the powers vested
23 in the Council by Section 1 (b) of Article VI of the
24 Constitution of the Tohono O'odham Nation, adopted by the Tohono
25 O'odham Nation on January 18, 1986, and approved by the Acting
26 Deputy Assistant Secretary - Indian Affairs (Operations) on March
27 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).
