

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Judicial Services Budget Amendment)

RES. NO. 92-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the  
2 Judicial Services Program under FY '88 P.L. 93-638  
3 Contract with the Bureau of Indian Affairs; and

4 WHEREAS, any amendments affecting the funding or funding levels  
5 of the contract shall be submitted for review and  
6 approval by the Tohono O'Odham Legislative Council; and

7 WHEREAS, an amendment has been submitted for review and approval  
8 by the Judicial Services Program.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
10 Legislative Council does hereby approve the amendment to  
11 the Judicial Services Contract.

12 BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and the  
13 Treasurer of the Tohono O'Odham Nation are hereby  
14 authorized to negotiate and execute the contract and any  
15 amendments thereto for the duration of the contract,  
16 provided however, that any amendments affecting the  
17 funding or funding levels of this contract shall be  
18 submitted for further prior approval by this Council.


19 The foregoing resolution was passed by the Tohono O'Odham  
20 Council on the 7th. day of April, 1988, at a meeting at which a  
21 quorum was present with a vote of 1,339.5 for; -0- against;  
22 300.5 not voting; and 01 absent, pursuant to the powers vested in  
23 the Council by Section 1 (f) of Article VI of the Constitution  
24 of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
25 Nation on January 18, 1986, and approved by the Acting Deputy  
26 Assistant Secretary - Indian Affairs (Operations) on March 6,  
27 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
28 Stat. 984).
