

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Disapproving Salaries for Judges)

RES. NO. 93-88

1 WHEREAS, the Tohono O'Odham Legislative Council passed
2 Legislative Order No. 57-88 "Referring Judge's Salary
3 Increase to the Budget & Finance and Judiciary
4 Committee" on March 8, 1988; and

5 WHEREAS, the Legislative Order directs the above mentioned
6 committees to address the issue of salary increases for
7 the Judges and bring the issue back to Council next
8 month; and


9 WHEREAS, the issue of the Judge's Salary increases was placed on
10 the April Legislative Council Agenda in accordance with
11 Legislative Order No. 57-88; and

12 WHEREAS, the Budget & Finance and Judiciary Committee informed
13 the Council that they were not able to address the
14 issue.


15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
16 Council that the salaries of the Judges not be approved.

17 The foregoing resolution was passed by the Tohono O'odham Council
18 on the 7th day of April, 1988 at a meeting at which a quorum
19 was present with a vote of 977.0 for; 610.5 against; 52.5 not
20 voting; and 02 absent, pursuant to the powers vested in the
21 Council by Section 1 (b) of Article VI of the Constitution of
22 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
23 on January 18, 1986, and approved by the Acting Deputy Assistant
24 Secretary - Indian Affairs (Operations) on March 6, 1986,
25 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
26 984).
