whereas, the Legislative Council did by Resolution No. 364-87 approve the FY 1988 budget for the Office of the Prosecution in the amount of \$46,924.00 to be funded from General Tribal revenues; and

whereas, the Legislative Council had previously determined that carryover funds in the amount of \$28,923.00 were available from a federal grant, the inclusion of which brought total budget for FY 1988 for the Office of the prosecution to \$75,847.00; and

whereas, the Judiciary Committee, the Domestic Affairs Committee, the Budget & Finance Committee and representatives from the Executive Branch of the Nation have reviewed the status of the Office of the Prosecution and have determined that the present funding level is inadequate to effectively operate the Office and to protect the interests of the Tohono O'Odham Nation.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approve a budget increase in the amount of \$27,360.00., a budget modification reflecting this increase along with justification thereof, is attached and made an integral part of this resolution, total new budget now \$103,207.00.

BE IT FURTHER RESOLVED that this amount of \$27,360.00 be appropriated from the "Reserve for Contingencies" line item of \$62,000.00 as approved under the Administrative Provisions portion of the fiscal year 1988 tribal funded budget.

The foregoing resolution was passed by the Tohono O'odham Council on the 27th. day of April, 1988 at a meeting at which a quorum was present with a vote of 1,375.5 for; 84.5 against; 179.0 not voting; and 04 absent, pursuant to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
