

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving budget increase for the Nation's Office of
the Prosecution in the amount of \$27,360.00)

RES. NO. 97-88

1 WHEREAS, the Legislative Council did by Resolution No. 364-87
2 approve the FY 1988 budget for the Office of the
3 Prosecution in the amount of \$46,924.00 to be funded
4 from General Tribal revenues; and

5 WHEREAS, the Legislative Council had previously determined that
6 carryover funds in the amount of \$28,923.00 were
7 available from a federal grant, the inclusion of which
8 brought total budget for FY 1988 for the Office of the
9 prosecution to \$75,847.00; and

10 WHEREAS, the Judiciary Committee, the Domestic Affairs Committee,
11 the Budget & Finance Committee and representatives from
12 the Executive Branch of the Nation have reviewed the
13 status of the Office of the Prosecution and have
14 determined that the present funding level is inadequate
15 to effectively operate the Office and to protect the
16 interests of the Tohono O'Odham Nation.

17 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does
18 hereby approve a budget increase in the amount of
19 \$27,360.00., a budget modification reflecting this
20 increase along with justification thereof, is attached
21 and made an integral part of this resolution, total new
22 budget now \$103,207.00 .

23 BE IT FURTHER RESOLVED that this amount of \$27,360.00 be
24 appropriated from the "Reserve for Contingencies" line
25 item of \$62,000.00 as approved under the Administrative
26 Provisions portion of the fiscal year 1988 tribal funded
27 budget.

29 The foregoing resolution was passed by the Tohono O'odham Council
30 on the 27th. day of April, 1988 at a meeting at which a quorum
31 was present with a vote of 1,375.5 for; 84.5 against; 179.0 not
32 voting; and 04 absent, pursuant to the powers vested in the
Council by Section 1 (d) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
