

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Human Services Program)

RES. NO. 99-88

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Human Services Program under FY '88 P. L. 93-638
3 contract with the Bureau of Indian Affairs; and

4 WHEREAS, such Tribal operations have been successful and
5 beneficial to the Tohono O'Odham Nation and its people;
6 and

7 WHEREAS, 25 CFR Section 271.20 of the Federal Regulations
8 requires that all proposals to recontract under P. L.
9 93-638 be submitted to the Tohono O'Odham Council for
10 approval at least 120 days prior to the contract
11 termination; and

12 WHEREAS, the Tohono O'Odham Council does desire to recontract for
13 provisions of these services during FY 1989; and

14 WHEREAS, the Tohono O'Odham Council has reviewed and approved the
15 Human Services Program Contract.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
17 Council that it does authorize and request the Bureau of
18 Indian Affairs to contract with the Tohono O'Odham
19 Nation under P. L. 93-638 regulations and procedures for
20 the provisions of services titled: Human Services.

21 BE IT FURTHER RESOLVED that the term of this contract shall
22 commence on October 01, 1988 and end on September 30,
23 1989.

24 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
25 that the Tohono O'Odham Nation will not fund or operate
26 the program in the interim while negotiations are still
27 being conducted and no executed contract has been
28 awarded by the Bureau of Indian Affairs.

29 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
30 that the Chairman, Vice-Chairman and Treasurer of the
31 Tohono O'Odham Nation are hereby authorized to negotiate
32 and execute this contract and any amendments thereto for
the duration of the contract, provided however, that any
